I am leaving my RV with *Dreamchasers RV of Burlington* who will try and sell the RV on a consignment basis. I understand this agreement is not part of any vehicle sale between *Dreamchasers RV of Burlington* and me. Initial _____

I am aware that *Dreamchasers RV of Burlington* requires a 30 day minimum agreement to have the opportunity to sell my unit. Initial _____

I agree that I will continue to carry full coverage insurance on my vehicle for demonstration while it is in the possession of *Dreamchasers RV of Burlington*. Initial _____

I guarantee to deliver the title to the dealer-consignee upon sale of the vehicle. Initial _____

I understand this agreement will expire in 180 days from date agreement was entered. Initial _____

I am aware that all items related to safety must be operational at time of sell. Non-functional or expired equipment will be replaced or repaired prior to dealer-consignee sell of vehicle (i.e. Smoke Detectors, LP Detectors, CO2 Detectors, Propane Tanks, Fire Extinguishers, Check Engine Light, etc.) at my expense prior to sale of vehicle. I acknowledge any amounts due to me or lienholder will be paid within ten days after delivery of the vehicle to the purchaser. I understand there is an additional \$200.00 fee for *Dreamchasers* to process any payoff to any lienholder on my behalf. Initial _____

Section V: Waiver and Release and Removal of Vehicle:

I understand that I am totally responsible for any and all losses or damages to my vehicle while at *Dreamchasers RV of Burlington*. Such losses and damage include but are not limited to theft, stolen tires, vandalism, (paint, contaminated gas, etc.), broken glass, and damaged sheet metal. I waive and release any and all claims against *Dreamchasers RV of Burlington* for all such damage and loss excepting that caused intentionally or negligently by *Dreamchasers RV of Burlington*.

Upon expiration of the Consignment and Sale Agreement or in the event the Consignor does not repair any damage to the vehicle or cure any default under the Consignment and Sale Agreement within five (5) days of notice from *Dreamchasers RV of Burlington* of such damage or default, I agree to remove said vehicle from *Dreamchasers RV of Burlington* property within 24 hours of demand and that I will be obligated for the damages, if any, due under the Consignment Agreement. *Dreamchasers RV* is authorized to have vehicle removed/impounded at my/our cost and expense should I fail to do so.
